Contractors/Tenders before quoting their rates may visit the site/school office during any working days for any information. The school committee or higher authority reserves the right to accept or reject any quotations without assigning any reason thereof.

The last date for submission of quotation is 11-08-2026 upto 1:00 P.M. The successful quotationer shall have to execute the work as per IS codes and standard Engineering practices after the work order is issued from this office.

Terms and conditions:

1. There should not be any overwriting or corrections in the quotation/Tender. If a figure is to be amended, it should be neatly scored out, the revised figure written above and the same attested with full signature and date. In the absence of such attestation the quotation is liable to be rejected.
2. The undersigned does not bind himself/herself to accept the lowest quotation and reserves the right to accept the quotation in whole or in part i.e, with respect to all the articles mentioned in the attached statement as he/she may decide.
3. On acceptance of the quotation it will become a contract and the contractor shall be bound by the terms and conditions of the quotation.
4. The person/persons whose quotation accepted, herein after called the contractor, shall deposit an earnest money which is 2% of total cost, shall be refunded in the event of rejection of the quotation. The earnest money will be forfeited in the event of failure to comply with the contract. In the event of acceptance of quotation/Tender, the earnest money will be adjusted towards Security Deposit. If the contractor is not agreeable to pay Security Deposit, the reasons therefore should be specified and the undersigned reserves the right to accept or reject the request.

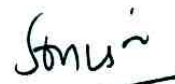

5. If the contractor fails to do work within the time stipulated in the letter of acceptance by the undersigned, the undersigned shall be at liberty to purchase the articles from the market or get the rest of the contract completed by any other person or firm and the difference of price, if any, shall be deducted from the earnest money/security deposit and in case any amount in excess of the security deposit is paid by the undersigned the contractor shall be liable to pay this amount.
6. The quantity may be increased or decreased at the discretion of the undersigned without assigning any reason.
7. The amount of security deposit shall be deposited shall be retained by the school/Institution for a period of six months from the date of completion of work as a safe guard against any defect appearing in the water proofing work within this warranty period of 8 years or more.
8. Prior to acceptance of the quotation/tender, the undersigned reserves the right to call for samples or demonstration and the contractor/Tenders shall be liable to give the demonstration free of cost.
9. Surface preparation, slope correction, treatment of cracks, joints and rainwater outlets shall be ensured before application of the waterproofing system.
10. The work shall be executed as per relevant IS codes and standard engineering practices.
11. The contractors shall be responsible for rectification of any leakage, seepage, or defects noticed during the warranty period at his own cost.
12. Payments shall be released only after satisfactory completion of the work and certification by the Architect/Engineer-in-charge.
13. Proper safety measures and protection of existing structures during execution shall be ensured by the contractor.
14. Quotation / Tender which do not comply agree with the above conditions are liable to be rejected.
